
## MOUNTING STYLES & LETTERS

ote: Minor variations in color may occur from plaque to plaque.




1. Concealed Threaded stud for concealed mounting to brick, stone or cement brick, stone or cement.




2. Rosettes & Anchors\* Expansion anchors for with Rosette covers.



3. Rosettes & Toggle Bolts\* Toggle bolts for hollow For installation on wall installation with Rosette covers.



4. Rosettes & Wood Screws\* wood surfaces with Rosette covers.



5. Invisible Frame (Additional cost) Angle clips attach to wall by screws, toggles or anchors; machine screws hold plaque to angle clips.



6. Stake Mount Inserts into ground or concrete.



# WILTON, CONNECTICUT SALES AGREEMENT TERMS AND CONDITIONS

#### 1. PRICES:

Quotations are for immediate acceptance and subject to change without notice. Prices are F.O.B. Wilton, Connecticut, packing containers charged to Buyer at Seller's cost.

#### 2. Warranties:

Seller warrants its products against defects in material or workmanship for one year subsequent to shipment. Such warranty shall be honored by replacement or repair, at the option of Seller, of the defective product, F.O.B. Wilton, Connecticut, only, provided that:

- (a). Written notice describing the defect is given by the Buyer to Seller and Seller consents in writing to shipment of the product, freight prepaid, to its factory in Wilton, Connecticut, by the Buyer; or
- (b). Proof of defect satisfactory to Seller is provided to it by written description and photographs or other visual aids; and
- (c). Seller determines to its satisfaction that such a product is defective in workmanship or material.

Warranties are limited as follows:

- (d). The product must have been used in accordance with the use for which it was designed.
- (e). Defective parts of any product shall be supplied by Seller. The cost of removal of such defective parts and the cost of its replacement shall be borne by the Buyer.
- (f). This warranty is the sole warranty of the Seller and NO OTHER WARRANTIES, EXPRESS OR IMPLIED, OF MERCHANTABILITY, FITNESS FOR USE OR OF ANY OTHER KIND OF NATURE ARE MADE BY THE SELLER.

#### 3. PRODUCT SUITABILITY:

Determination of the suitability of Seller's product for the uses and applications contemplated by the Buyer are the sole responsibility of the Buyer. Buyer assumes all risk and liability for the use or application of Seller's products, whether used singly or in combination with other products.

#### 4. CLAIM PERIOD:

Claims related to non-conforming product shall be made by written notice within thirty (30) days after delivery. All other claims shall be made within (90) days after delivery. Buyer's failure to give Seller written notice of any claim within the applicable period shall constitute an absolute and unconditional waiver of such claim.

#### 5. LIMITATION OF LIABILITY:

Buyer's exclusive remedy shall be made and no claim of any kind, whether based on contract, breach of warranty, negligence or otherwise, shall be greater in amount than the purchase price of the product in respect of which damages are claimed. Seller shall not be liable for any special, punitive, incidental or consequential damages.

#### 6. INDEMNITY AGREEMENT:

Buyer shall defend indemnity and hold Seller harmless from and against all claims, liabilities, costs and expenses including, but not limited to, those related to injury to or death of Buyer's employees arising from or connected with the possession, handling, processing or use of the product by Buyer or others. Seller may participate in the defense of any such claim for the further protection of its own interest.

#### 7. FORCE MAJEURE:

Seller shall not be responsible or liable for non-performance or delay in performance directly or indirectly caused by an occurrence beyond Seller's reasonable control, including act of God, flood, fire, embargo, explosion, riot, war, national emergency, sabotage, accident, labor dispute or shortage, governmental, laws, ordinances, rules and regulations, whether valid or invalid (including, but not limited to, priorities, requisitions, allocations and price adjustment restrictions), good faith compliance with Court order, breakdown of machinery or apparatus, shortage or inability to obtain or make use of suitable material, equipment, fuel, power or transportation, or any other similar or different occurrence. Seller shall have the right to omit during the period of such contingency all or any portion of the quantity ordered hereunder, whereupon the total quantity ordered hereunder shall be reduced by the quantity so omitted.

#### 8. ALLOCATION:

In the event of any cause or circumstance excusing Seller, Seller shall have the right to utilize its available production and/or supply to satisfy its own requirements, including those of its subsidiaries and affiliates, in full, and to allocate any remaining production and/or supply among its customers, including those not under contract, in a fair and reasonable manner, and Buyer hereby releases Seller from responsibility or liability for any resulting incomplete fulfillment.

#### 9. FAIR LABOR STANDARDS:

Seller certifies that the ordered products are produced in compliance with all applicable requirements of Section 6, 7 and 12 of the Fair Labor Standards Act, as amended, and or regulations and orders of the United States Department of Labor issued under Section 14 thereof.

#### 10. MODIFICATION:

These conditions may not be modified or waived other than in writing by an officer of Seller.

#### 11. PAYMENT:

50% deposit is required to activate all orders. The balance is due upon completion and prior to shipping. All net invoices rendered to Buyer pursuant to this order shall be paid within thirty (30) days of the due date thereof. Buyer shall pay Seller interest on all amounts due and unpaid after thirty (30) days at the rate of 1.5% for each subsequent thirty (30) day period, or part thereof, until such amounts shall have been paid in full. If any law governing this agreement causes such rate to be unlawful, such rate shall be reduced to the lawful rate.

It is certainly not our intention to mislead our customers into thinking we have an item that we no longer manufacture. ## ABOUT OUR CAST STONE

All "Stone" products made by Kenneth Lynch & Sons are actually "Cast Stone" which is a concrete product. This firm makes no products of cut or shaped natural stone. The concrete in our cast stone products contains various dimensions of limestone aggregate, some mason's sand, Type 2 Portland Cement, a concrete superplasticiser and only just enough water to make the mix workable (a maximum of a 25 % slump). This applies to all descriptions in the *Encyclopedia of Garden Ornament Book No. 2074, Garden Ornament Book No. 2076* and *2076A* and *B, Sundial Book No. 7374, Benches Book No. 9074* and to all descriptions in this Edition.

## ABOUT OUR LEAD

Our Lead products are made of 99.5% pure lead. Where necessary they are reinforced with Brass, Bronze or Stainless Steel to give them the strength that Lead does not have. We recommend that safeguards be taken to avoid any human ingestion of water from objects (birdbaths, fountains, etc.) made of Lead.

## **ABOUT OUR BENCHES**

On our benches which have wood seats we use Ipe (Tabebuia) as our standard specified wood. It is an even brown color when freshly milled and weathers to a very nice silvery grey color over time. These woods are naturally antifungal, very dense and very hard. Vertical grain Douglas Fir is still available on special order.

## ABOUT OUR WEATHERVANES

Our weathervanes are constructed of non-ferrous materials only, Copper, Bronze, Aluminum, and Stainless Steel. They are manufactured in the simplest manner for years of trouble free use.

## **ABOUT OUR SUNDIALS**

Our sundials are made of Bronze, Lead, Cast Stone, or Iron, depending on the choice of sundial. We try, within the limits of practicality, to make them as close to a working instrument as possible, keeping in mind that they are intended to be ornaments.
