WARRANTY INFORMATION

Our focus at Florentine Classics is to create durable, elegantly classic, individually crafted aluminum furniture for private estates and exclusive venues. Genuine and traditionally styled; we will continue our tradition of quality by ensuring each of our hand assembled and finished pieces is scrutinized by our craftsmen every step of the process.

WARRANTY FOR FLORENTINE CLASSICS

Aluminum Furniture: Cast and extruded aluminum furniture frames are warranted to the original residential purchaser; frames shall be free from defects in material and workmanship for a period of 15 years. Powder coated and painted surfaces are warranted to be free of defects for a period of 3 years. Cushion construction is warranted for a period of 1 year, excluding customer's own material (C.O.M.). Warranty does not cover accidents, normal wear and tear, scratches, chips and blemishes, immersion in water or acts of nature.

Such warranty shall be honored by replacement or repair, at the option of Kenneth Lynch & Sons, of the defective product with the same product or similar product if the original product is no longer available, F.O.B. Oxford, Connecticut, only, provided that:

- (a) Written notice describing the defect is given by the Buyer to Kenneth Lynch & Sons and Kenneth Lynch & Sons consents in writing to shipment of the product, freight prepaid, to its factory in Oxford, Connecticut, by the Buyer; or
- (b) Proof of defect satisfactory to Seller is provided to it by written description and photographs or other visual aids; and
- (c) Kenneth Lynch & Sons determines to its satisfaction that such a product is defective in workmanship or material.

Warranties are limited as follows:

- (d) The product must have been used in accordance with the use for which it was designed as well as all recommended installation procedures were followed.
- (e) Defective parts of any product shall be supplied by Kenneth Lynch & Sons. The cost of removal of such defective parts and the cost of its replacement shall be borne by the Buyer.
- (f) This warranty is the sole warranty of the Kenneth Lynch & Sons and NO OTHER WARRANTIES, EXPRESS OR IMPLIED, OF MERCHANTABILITY, FITNESS FOR USE OR OF ANY OTHER KIND OF NATURE ARE MADE.

PRODUCT SUITABILITY:

Determination of the suitability of Kenneth Lynch & Sons product for the uses and applications contemplated by the Buyer are the sole responsibility of the Buyer. Buyer assumes all risk and liability for the use or application of Kenneth Lynch & Sons products, whether used singly or in combination with other products.

CLAIM PERIOD:

Claims related to non-conforming product shall be made by written notice within ten (10) days after delivery. All other claims shall be made within the specified product's length of warranty from the date of invoice. Buyer's failure to give Kenneth Lynch & Sons written notice of any claim within the applicable period shall constitute an absolute and unconditional waiver of such claim.

MAINTENANCE:

- The end user shall perform yearly maintenance to prolong functionality and appearance of the furniture.
- Clean furniture twice a year with mild soap solution.
- Store furniture right side up. Do not stack.
- Inspect and replace nylon glides as necessary.
- Inspect painted finishes for chips; clean and apply touch up.
- If desired, every 3 – 5 years apply clear satin lacquer to bring back sheen to painted surfaces.
